Performance Requirement

Criteria for selection for pool events for 2014 Junior Pan Pacific Championships, Maui, Hawaii.

Individual events:

To be selected for individual events at the 2014 Junior Pan Pacific Championships, Maui, Hawaii athletes are required to:

1. Record a time equal to or better than the times detailed below at the Selection Event.

- 3. Only times achieved in the A final in each event at the Selection Event will be considered.
- 4. Should three or more athletes achieve the same qualifying time at the Selection Event then the athletes heat time in that event at the Selection Event will be used to determine which athlete is selected.
- 5. Relay splits and other split times will not be considered for selection for an individual event nor for selection to relays.

| | Selection for relays for the 2014 Junior Pan Pacific Championships will be made from within the team selected for the 2014 Junior Pan Pacific Championships, Maui, Hawaii. | |
| | The final composition of the relay teams will be determined by the coaching staff and team management at the 2014 Junior Pan Pacific Championships, Maui, Hawaii in their sole discretion. | |
| | The SNZ Selectors philosophy is to ensure the best possible Relay Team is on the blocks representing New Zealand at the Junior Pan Pacific Championships. | |
| Team Size & Announcement | Team size for individual events will be in accordance with the Junior Pan Pacific's Association rules. If the number of swimmers meeting the performance criteria exceeds the limit, the highest ranked swimmers who satisfy the selection criteria will be selected. | |
| | The selection of the athletes that have met all of the Eligibility and Performance Requirements will be announced on or about the 4th May 2014. | |
| Notes | SNZ may amend these selection criteria at any time, by giving reasonable notice to all swimmers eligible for selection. | |
| | 2. If a swimmer is unable to satisfy SNZ requirements after selection and needs to withdraw from the team, SNZ may at their discretion select the next swimmer who has met all the eligibility and performance requirements. SNZ reserve the right to request that any swimmer being considered for selection under the provisions of this clause undertakes a fitness test, the parameters of which will be determined by the SNZ High Performance Director at his sole discretion. | |
| | 3. In the event that a swimmer is unable to compete at the Selection Event due to extenuating circumstances, the previous performances in a long course event at a competition acceptable to SNZ Selectors and SNZ High Performance Director, during the period between 1 st January 2014 and the Selection Event may be considered by the SNZ Selectors. If the previous performance is to be considered, then the fastest qualifying time, irrespective of where it was achieved, shall have priority. | |



| | In the event of illness or injury a medical certificate will be requested, indicating the current and future performance impact of the condition. Selection of a swimmer, as outlined above, will be subject to confirmation of their satisfactory return to training. This process is to include a test (under legitimate competitive conditions i.e. starter, turn judges and electronic timing) in the event selected. This test must be performed by a designated date decided by the SNZ High Performance Director in consultation with the SNZ High Performance | |
