#### **Central North**

CM: Went to Junior Championships to meet the team. Jeannie introduced Gavin to people. Great systems in place. Going back in Dec for their next meet. Will complete assessments.

BP: Visited recently. Steve Knox doing well. Plan around each club having referees. CNI completed 2 Nat Referees and 1 Nat IOT. Confusion around changes to the backstroke rule.

WK: Quiet with a reduction in the number of events. Thames soon to hold an IOT seminar.

#### **Lower North East**

WN: Outlined the policies and pathway Swimming Wellington has developed for technical officials. General discussions on the content and feedback provided for Matt to take back to SW panel. TAC would like to use this as a template for a national strategy, with the support of Swimming Wellington to use their resource. 3 National IOT qualifications.

HBPB: Nothing to report. WAI: Little happening.

#### **Lower North West**

Manawatu will not select a technical official as team manager to get them onto pool deck. Emphasis that the national meets are for everyone not just the region hosting.

# **Upper South**

CB: New dynamic with the addition of ED. Upcoming seminars in WC and Canterbury. Utilise an introduction to officiating to promote officialdom. 400 have been circulated in CB. Some requirements misunderstandings in ED.

NM: 1 Regional Ref 4 National IOTs. Good things happening.

#### **General Business:**

General Business is not in any particular order:

- 1. Current Set Up of SNZ
  Kent covered the new org structure and described the new roles within the organisation especially those individuals that will work with the technical officials.
- 2. Regulations and By-laws Jo & Lesley Feedback on the current received and discussed.
- 3. Freestyle Races Jo & Lesley Judge of Strokes should be sitting down. JOS's are fine to walk if sitting for a long time. You don't have to walk but can. To clarify at pre event briefings. It's just important to pick the right moment to go for a walk.
- 4. Advertising on Caps Status Quo
- 5. Pool Deck Passes Jo Greater policing of wearing passes needs to be undertaken especially at WRAC. Swimmers get lost coming out of marshalling.
- 6. Medical Card Lesley
  Situation at NZ SC with swimmer with a medical condition.
  Lesley would like to see a medial card created with
  information on the medical condition and a signature from
  their specialist. This would come inline with the FINA rule for
  relay replacements. Committee agreed and Lesley will
  encourage the swimmer in questions to get one made up.
- 7. Introduction to Officiating Lesley presented with a New Zealand version to be create for publication on the SNZ website.

- 8. 2014 Competition Calendar Jo Concerns about SC and Sec Schools back to back. Will be a real struggle to get enough officials.
- 9. Announcer Pathway Jo
  Ross to circulate announcers notes from Peter Graham's.
  Decision made that music can be played during 800 and 1500 events. Background music at a low volume.
- 10.Swimwear Jo

Is there the need to revisit open in regard to FINA approved togs only being worn? Lesley let us know that there is a new system coming out with the ability to scan the label and will get an instant yes/no approval. Decision to hold off until we have the capability to do this with a scanner.

- 11.JOS Qualification Ross
  - Draft submitted by Dave Beattie with Ross presenting. Initial discussions and decision made for Ross to do some work on it and come back to the group for more work and distribution.
- 12.Forms Protest, Disqualification, Wording for Disqualification etc Jo

Protest Form - New form to be placed on the Swimming New Zealand website for use from here on. Discussion on the late withdrawal to stay the same at \$50 with the protest fee to be increased \$100. Two major reasons, one is to come closer to the FINA standard 100 Swiss Francs and second that there should be a different fee for Late Withdrawals in comparison to Protests. The process for a protest is far more involved and time consuming. Decision that more discussion needed and would be revisited at next meeting.

DQ form- small changes made and this will also be placed on the SNZ website for use.

DQ Wording Card - Lyn was working on this for update. Need to continue to let referees know that it is only a guide. Original reason for form was for language issues at international events. Need to inform regions that if referees are demanding that only the wording from the wording card is used TAC members must be informed of this so that the practice can be stopped. Suggestion that a watermark be placed on the card saying guide. Need to start to reeducate officials at event briefings talking about the guide status of the card.

Adjustments made to the Wording Card based on the changes to the FINA rules and Guide Only water marked on the sheet. Posted on the SNZ website.

# 13.General Business

Relays- discussions on having only one swimmer marshal for each relay team. Would struggle to make it work at WRAC.

Visitor (All Comers) records to be reinstated. Lesley to investigate and start to compile records. SNZ to assist with supplying of past meet results.

Sport Science- Request for time of infraction from Sport Science staff at HPNZ to be able to use footage for education. Concern that it could cause a integrity issues with the officials.

Meet Mobile – Need to find the button to stop results going online until result is cleared

#### 14. New Database

Update on where Swimming New Zealand is at with the development of a new database. Things that are relevant to Technical Officials were discussed with suggestions for additional things to be in the database. Talked about applying for meets to officiate at and also claiming a role from a meet that has been completed. These can be related to achieving qualifications.
