NZ Spring Competitition - Bill

Initiative by Swimming New Zealand on a happy hour for officials. While some people couldn't stay this was well received amongst the officials that stayed.

Programming – 50m events at the end of the days programme. Preferable that it is not at the end of the session. Made recommendation previously regarding this. Order of Events was done while Sandra was overseas by Frank Tourelle. Note for future regarding Order of Events

Lack of concentration during longer events was noted and needs to be addressed. Same thing happened in Christchurch. Need to find out how other countries handle the situation.

It is important that the Chief IOT's are not turning lap counters during 800 and 1500 events so that they can check the lap counters.

One timekeeper per lane – worked fine, however it was still difficult to get timekeepers.

Victory ceremonies – protocol, timing and production of the timing schedule worked really well.

A suggestion was made that at NZ Youth and Opens the dais be at the start end as this makes it easier to get the swimmers to the presentations with the warm down pool being at that end.
