Full discussion with regards to Referees Grading etc

At last meeting this was left with Bill to discuss with colleagues. Most spoken to don't have a great interest. They know their referees. Lesley spoke to Australia. They have an assessment process.

NZ Gradings currently time based rather than skill based. Obligation to move them through thprocess. Remove grading system. Some people may view this as a negative thing.

Formal assessment programme – performance is assessed. Constructive with feedback. Committee have a responsibility to assess referees on a formal basis. People to assess from outside. More formally structured than previously.

Somebody other than Meet Director – at National meet with officials assessments.



63 people on referees grading list. Applications from 28 people. Appointed 23 referees. So 23 would be assessed each season. Some don't do anything outside their region.

Implications of getting rid of the gradings

No major implications. If open as to why it is being done.

Qualify as a National Referee have this forever.

If official does not referee for a period Reassessment would be required if they want to work at a National Competition.

Should there be expiry in relation to this as opposed to having it forever??

SNZ Education courses after a period of time need to revalidate.

Currently Referee grading can do at other sanctioned meets.

Revalidation – re-sit the full examination or just go through a revalidation process.

Assessing their ability on a practical level.

Need to write a formal assessment – that everyone is aware of.

- Knowledge and applying the rules
- Professionalism
- Communications skills

Recommendations

Put the decision of removing the referee gradings out for feedback. We are considering doing the following and ask for feedback from the regions and officials.

Assessment at every National Competition. Referees/JOS and Starters.

TAC Member not appointed as a referee.

Lesley to draft something and an assessment paper.

Paul to ask Swimming Australia for their assessment process and forms.

Feedback by 8th December. Paper to be distributed.
