## **Item 7: International Meets & Opportunities**

- 7.1 Update provided on International Meets calendar CYG discussed technical nominations now confirmed
- 7.2 Potential Open Water event being planned for Noumea now confirmed
- 7.3 SNZ and the TAC will consult with Para Swimming NZ to gauge the best approach to gaining more accredited para swimming officials

## **Item 8: SNZ Meets**

- 8.1 Meet Flyers & Meet Information SNZ events for ensuring correct information released and updated as necessary
- 8.2 Late Withdrawals payments being received promptly
- 8.3 Use of radios at SNZ meets need limiting to essential personnel
- 8.4 IOT's on Pool Deck IOTs can use rule reference card on pool deck
- 8.5 Chief IOT at SNZ Meets should be experienced officials
- 8.6 Zonal Championships Logistics and planning for the event are well on track.

### **Item 9: Regional Meets**

- 9.1/2 Standard template for Meet Flyers/Information
  The group, with the assistance from SNZ staff to develop a basic meet flyer/information template that can be edited to suit the meet it is being used for ensuring that all regional meets are being conducted in line with the required SNZ Rules & Regulations.
- 9.3 Minimum number of qualified officials at meets
  For a meet's results to be endorsed there must be the correct
  number of officials, otherwise, times achieved at that meet may not
  be eligible as qualifying times for other meets.
  It was agreed that when a meet results file is sent to SNZ for
  authorisation, it needs to be accompanied by a signed Officials
  Approved Meet Results form
  SNZ to communicate these minimum requirements to the
  regions and clubs.
- 9.4 Number of timekeepers per lane for manual meets clarified.

  As there is no longer a National Timekeepers qualification wording on the Officials Approved Meet Results form to be amended accordingly.
- 9.5 Mixed gender events
  It was acknowledged that due to time constraints and limited numbers regions do run mixed gender events.
  A motion was put forward and carried that for all Regional Championship Meets and above, all events (excluding mixed relays) must be swum as separate gender events.
- 9.6 Para Swimmers Inclusion
  Concerns raised regarding para swimmers entering meets and
  events for which they do not qualify. Need to ensure that database
  shows swimmers that are in para category.



### **Item 10: Officials**

10.1 SNZ Memberships – Officials & Coaches
To be a recognised for meet endorsement an official must be a
current financial 'voting' member of SNZ.

If an official's memberships lapses for a period of 4 years or more
there accreditation/qualification will no longer be valid.
For NZSCTA coaches to have access to pool deck during SNZ meets
they will need to be members of SNZ. SNZ and NZSCTA are
working on an agreement.

- 10.2 Referee Qualification & CRS Qualification
  National Referees to be rotated through CRS position at SNZ Meets
- 10.5 All National Exam Papers to be updated. Referees exam to include larger section on CRS role. Matt Meehan to review
- 10.6 Regional officials to be encouraged to attend national meets to gain more experience
- 10.7 Meet Assessments

Assessment process essential for the development of newer officials.

Gavin, Matt and Ross to work on assessment documents that reflect different requirements for new and more experienced officials.

#### **Item 11: SNZ Forms**

11.1 Protest form, DQ form and Penalty updated and agreed (now available on SNZ website)

#### **Item 12: Protests**

12.1 Agreed that SNZ and the TAC should create a brief document highlighting the correct process to be followed when submitting a protest.

### Item 13: SNZ By-Laws - FINA compliance of pools

13.1 Current FINA requirements discussed. TAC to request regions to supply a current survey of each pool used for competition.

### Item 14: Up-Coming OHS / Work Safe Requirements

- 14.1 SNZ confirmed it does have a dedicated work safe plan that is implemented to protect all SNZ members during meets.
- 14.2 It was agreed that the TAC need to be aware of the impact of any forthcoming legislation changes and recommended that SNZ ensure that any plans that are required are met and delivered at each national meet.
